THE REGENT OF GRESIK,

Considering: a. that in order to guarantee smooth operational activities, improve water service, and maintain the quality and quantity of water produced and managed by the Giri Tirta Regional Water Company of the Regency of Gresik, while still considering the public's ability to pay and equitable water usage, it is necessary to amend several provisions on the applicable tariff amounts in Regents Regulation Number 1 of 2018 on Water Tariffs at the Giri Tirta Regional Water Company of the Regency of Gresik;

b. based on the considerations referred to in point a, it is necessary to issue a Regional Regulation on Amendment to Regents Regulation Number 1 of 2018 on Water Tariffs at the Giri Tirta Regional Water Company of the Regency of Gresik;

DECIDES:

To enact: THE REGENTS REGULATION ON AMENDMENT TO REGENTS REGULATION NUMBER 1 OF 2018 ON WATER TARIFFS AT THE GIRI TIRTA REGIONAL WATER COMPANY OF THE REGENCY OF GRESIK.

Article I

The Appendix in Regents Regulation of Gresik Number 1 of 2018 on Water Tariffs at the Giri Tirta Regional Water Company of the Regency of Gresik (Regional Gazette of the Regency of Gresik of 2018 Number 1) is amended, to be as stated in the Appendix which is an inseparable part of this Regents Regulation.

Article II

1. The tariff provisions in accordance with this Regent's Regulation shall come into effect for water usage in May 2024, which will be billed in June 2024.
2. This Regents Regulation shall come into force on the date of its promulgation.

In order for everyone to know this, the promulgation of this Regents Regulation is ordered with its placement in the Regional Gazette of the Regency of Gresik.
