The Regent of Gresik,

Considering: a. that with the establishment of the Junior High School through the Decision of the
Regent of Gresik

Number: 421/406/HK/437.12/2021 on the Permit

for the Establishment of State Junior High School 34 Gresik,

and the National School Code Number of the Junior High School is established as Number:
70012489;

b. that based on the considerations referred to in point a, it is necessary to issue a Regional
Regulation

on the Second Amendment to Regents Regulation

DECIDES:

To Enact: A REGENTS REGULATION ON THE SECOND AMENDMENT TO REGENTS REGULATION NUMBER 32 OF 2018 CONCERNING THE STATUS, ORGANIZATIONAL STRUCTURE, DUTIES, FUNCTIONS, AND WORK PROCEDURES OF THE TECHNICAL IMPLEMENTING UNIT OF FORMAL EDUCATION UNITS, NON-FORMAL EDUCATION UNITS OF THE REGENCY OF GRESIK.

Section I

The provisions in Regents Regulation of Gresik Number 32 of 2018 concerning the Status, Organizational Structure, Duties, Functions, and Work Procedures of the Technical Implementing Unit of Formal Education Units, Non-Formal Education Units of Gresik Regency (Regional Gazette of Gresik Regency of 2018 Number 32) as amended by Regents Regulation Number 34 of 2020 concerning Amendments to Regents Regulation Number 32 of 2018 concerning the Status, Organizational Structure, Duties, Functions, and Work Procedures of the Technical Implementing Unit of Formal Education Units, Non-Formal Education Units of Gresik Regency (Regional Gazette

of Gresik Regency of 2020 Number 35) are amended as follows:

1. The provisions in Appendix II are amended to read as set forth in Appendix I, which is an inseparable part of this Regents Regulation.

Section II

This Regents Regulation shall come into force on the date of its promulgation.

In order that everyone may be aware of it, it is ordered that this Regents Regulation be promulgated by placing it in the Regional Gazette of Gresik Regency.
