AT THE INDONESIAN RED CROSS, REGENCY OF GRESIK

BY THE BLESSINGS OF ALMIGHTY GOD

THE REGENT OF GRESIK,

Considering: a. that in connection with the increasing costs of processing and serving blood donors, it is deemed necessary to make adjustments to the Replacement Costs for Blood Processing and Blood Components;

b. that based on the considerations referred to in (a), it is necessary to issue a Regent Regulation on Replacement Costs for Blood Processing and Blood Components at the Indonesian Red Cross, Regency of Gresik;

Law Number 23 of 2014 on Regional Government (State Gazette of the Republic of Indonesia of 2014 Number 244, Supplement to the State Gazette of the Republic of Indonesia Number 5587), as amended several times lastly by Law Number 9 of 2015 on the Second

Amendment to Law Number 23 of 2014 on Regional Government (State Gazette of the Republic of Indonesia of 2015 Number 58, Supplement to the State Gazette of the Republic of Indonesia Number 5679); 4. Law Number 36 of 2009 on Health (State Gazette of the Republic of Indonesia of 2009 Number 144, Supplement to the State Gazette of the Republic of Indonesia Number 5063); 5. Law Number 12 of 2011 on the Formation of Legislation (State Gazette of the Republic of Indonesia of 2011 Number 82, Supplement to the State Gazette of the Republic of Indonesia Number 5243); 6. Law Number 1 of 2018 on the Red Cross (State Gazette of the Republic of Indonesia of 2018 Number 4, Supplement to the State Gazette of the Republic of Indonesia Number 6180); 7. Government Regulation Number 7 of 2011 on Blood Services (State Gazette of the Republic of Indonesia of 2011 Number 18, Supplement to the State Gazette of the Republic of Indonesia Number 5197); 8. Regulation of the Minister of Health Number 83 of 2014 on Blood Transfusion Units, Hospital Blood Banks, and Blood Transfusion Service Networks (State News of the Republic of Indonesia of 2014 Number 1756); 9. Regulation of the Minister of Home Affairs Number 80 of 2015 on the Formation of Regional Legal Products (State News of the Republic of Indonesia of 2015 Number 2036) as amended by Regulation of the Minister of Home Affairs Number 120 of 2018 (State News of the Republic of Indonesia of 2018 Number 157); 10. Regulation of the Governor of East Java Number 41 of 2014 on Guidelines for Replacement Costs for Blood Processing at Blood Transfusion Units in East Java Province;

DECIDES:

To Enact: REGULATION OF THE REGENT ON REPLACEMENT COSTS FOR BLOOD PROCESSING AND BLOOD COMPONENTS AT THE INDONESIAN RED CROSS, REGENCY OF GRESIK.

CHAPTER I

GENERAL PROVISIONS

Article 1

1. Region means the Regency of Gresik.

2. Regent means the Regent of Gresik.
3. Indonesian Red Cross, hereinafter referred to as PMI, means the PMI of the Regency of Gresik.
4. Blood Donor Unit, hereinafter referred to as UDD, means a health service facility that organizes blood donation, blood processing, blood provision, and blood distribution.
5. Blood service means a health service effort that utilizes human blood as a basic material for humanitarian purposes and not for commercial purposes.
6. Blood service efforts are health service efforts that include planning, mobilization and preservation of blood donors, blood provision and management, blood distribution, and medical actions of giving blood to patients for the purpose of curing diseases and restoring health.
7. Blood means blood obtained from healthy volunteer blood donors who meet the donor selection criteria, prioritizing the donors health.
8. Blood provision is a series of taking and labeling donor blood, disease prevention, blood processing, and storage of donor blood.
9. Plasma is the separation of plasma derivatives into plasma products by applying technology in blood processing.
10. Blood Donor is a person who donates blood or components thereof to patients for the purpose of curing diseases and restoring health.
11. Hospital Blood Bank, hereinafter referred to as HBB, is a service unit in a hospital that is responsible for the availability of safe, quality, and sufficient blood for transfusion to support health services in the hospital.
12. Replacement Costs for Blood Processing, hereinafter referred to as RCBP, means all costs used in the process of producing safe, healthy, and quality blood and/or blood components according to applicable standards and calculated rationally and non-profit (without seeking profit).
13. Blood Compatibility Crossmatch is the main examination before blood transfusion by checking the compatibility between the patients blood and the donors blood so that the blood issued from the UDD is truly compatible.

CHAPTER II

RCBP AND BLOOD COMPONENTS

Article 2

(1) The calculation of RCBP is based on the calculation of the unit cost of blood processing and service, taking into account the costs of operational activities in managing and serving blood as well as for the development and improvement of blood services at the PMI UDD.

(2) The amount of RCBP as referred to in section (1) is as follows:

a. BPJS Participants and Non-BPJS Patients and Compatibility Crossmatch conducted at the UDD;

Rp. 355,000.00

and

b. HBB and Compatibility Crossmatch conducted at the Government/Private HBB. Rp. 330,000.00

CHAPTER III

PAYMENT OF RCBP

Article 3

(1) The payment of RCBP for blood users is made directly when taking blood or blood components at the PMI UDD.

(2) For blood users who are covered and/or guaranteed by an Institution or Company or Health Insurance that has a Cooperation Agreement with the PMI UDD, the payment system is carried out based on the agreement as stipulated in the Cooperation Agreement.

(3) For HBB and/or other UDDs, the payment system is carried out based on the agreement as stipulated in the Cooperation Agreement.

Article 4

RCBP can be returned to the blood user if the blood has not been handed over by the PMI UDD to the blood user.

CHAPTER IV

FINAL PROVISIONS

Article 5

Upon the commencement of this Regent Regulation, Regent Regulation of Gresik Number 4 of 2016 on Replacement Costs for Blood Processing and Blood Components at the Indonesian Red Cross, Regency of Gresik (Gresik Regency Regional News of 2016 Number 290) is revoked and declared no longer valid.

Article 6

This Regent Regulation shall come into force on the date of its promulgation.

In order for everyone to know, it is ordered that this Regent Regulation be promulgated by placing it in the Gresik Regency Regional News.
