AMENDMENT TO THE REGULATION OF THE REGENT OF GRESIK
NUMBER 26 OF 2014 ON WELFARE ALLOWANCES FOR
LEADERSHIP AND MEMBERS OF THE REGIONAL HOUSE OF REPRESENTATIVES OF THE
REGENCY OF GRESIK FOR THE TERM OF OFFICE 2014 TO 2019

BY THE BLESSINGS OF ALMIGHTY GOD

The Regent of Gresik,

Considering: a. that based on the provisions of Article 20 section (3) of Government Regulation Number 24 of 2004 concerning the Position, Protocol, and Finances of the Leadership and Members of the Regional House of Representatives of the Regency of Gresik, as amended several times, most recently by Government Regulation Number 21 of 2007, the provision of Housing Allowances must consider the principles of propriety, fairness, and rationality as well as applicable local price standards;

b. that based on the results of the Appraisal Value study by the Independent Public Appraisal Service Office Asmawi and Partners Number: 153/AA/LPC/IX/2015 dated October 28, 2015 concerning the Report on the Assessment of Assets and Rental Value of Official Residences, it is necessary to amend the amount of Housing Allowances for the Regional House of Representatives of the Regency of Gresik;

c. that based on the considerations referred to in points a and b, it is necessary to issue a Regional Regulation on Amendment to the Regulation of the Regent of Gresik Number 26 of 2015 concerning Welfare Allowances for Leadership and Members of the Regional House of Representatives of the Regency of Gresik for the Term of Office 2014 to 2019;

DECIDES:

To Enact: A REGENTS REGULATION ON AMENDMENT TO THE REGULATION OF THE REGENT OF GRESIK NUMBER 26 OF 2015 CONCERNING WELFARE ALLOWANCES FOR LEADERSHIP AND MEMBERS OF THE REGIONAL HOUSE OF REPRESENTATIVES OF THE REGENCY OF GRESIK FOR THE TERM OF OFFICE 2014 TO 2019.

Article I

Several provisions of the Regulation of the Regent of Gresik Number 26 of 2015 concerning Welfare Allowances for Leadership and Members of the Regional House of Representatives of the Regency of Gresik for the Term of Office 2014 to 2019 (Regional Gazette of the Regency of Gresik of 2014 Number 752) are amended as follows:

1. The provisions of Article 6 are amended to read as follows:

Article 6

(1) Housing Allowance is given to the leadership of the Regional House of Representatives who have not yet obtained an official residence and to members of the Regional House of Representatives who have not yet obtained an official residence.

(2) The Housing Allowance as referred to in section (1) is given in the form of money including Income Tax (PPH Article 21) and is paid monthly.

(3) The amount of the Housing Allowance as referred to in section (2) is as follows:

a. Chairman of the Regional House of Representatives: IDR 14,900,000 (fourteen million nine hundred thousand rupiah) per month.

b. Deputy Chairman of the Regional House of Representatives: IDR 13,500,000 (thirteen million five hundred thousand rupiah) per month.

c. Member of the Regional House of Representatives: IDR 12,000,000 (twelve million rupiah) per month.

(4) In the event of unsuitability and other reasons for the official residence of the leadership of the Regional House of Representatives and the official residence of the members of the Regional House of Representatives, a substitute housing allowance may be provided.

Article II

This Regents Regulation shall come into effect on the date of its promulgation.

In order for everyone to know, order the promulgation of this Regents Regulation by placing it in the

Regional Gazette of the Regency of Gresik.
