REGULATION OF THE REGENT OF GRESIK

NUMBER 26 OF 2013

ON

STANDARD OPERATING PROCEDURE

OF THE REGIONAL POLICE AND PUBLIC ORDER AGENCY

BY THE BLESSINGS OF ALMIGHTY GOD

The Regent of Gresik,

Considering: a. that in order for the implementation of activities and performance of the Regional Police and Public Order Agency to run smoothly, with the hope of encouraging a better process of governance, it is necessary to accelerate a proper, effective, efficient and integrated system of administration within the regional apparatus;

b. that to provide certainty in the performance of the duties of the Regional Police and Public Order Agency to be effective and efficient, there is a need for a Standard Operating Procedure as a fixed procedure for the implementation of tasks;

c. that in accordance with Article 6 section (2) of Regulation of the Minister of Home Affairs Number 54 of 2011 on the Standard Operating Procedure of the Regional Police and Public Order Agency, it is stated that the technical guidelines for the SOP of the Regional Police and Public Order Agency of regencies/cities are determined by the regent/mayor;

d. that based on the considerations as referred to in (a), (b), and (c), it is necessary to issue a

Regional Regulation on the Standard Operating Procedure of the Regional Police and Public Order Agency;

DECIDES:

To enact: REGIONAL REGULATION ON THE STANDARD OPERATING PROCEDURE OF THE REGIONAL POLICE AND PUBLIC ORDER AGENCY.

CHAPTER I

GENERAL PROVISIONS

Article 1

In this Regulation of the Regent:

1. Regional Government means the Regional Government of the Regency of Gresik.
2. Regional Police and Public Order Agency, hereinafter referred to as Satpol PP, is a regional government apparatus in maintaining and organizing public order and community tranquility and enforcing Regional Regulations, Regents Regulations and Regents Decisions.
3. Regional Police and Public Order personnel are members of the Satpol PP as regional government apparatus in enforcing regulations in the region and organizing public order and community tranquility.
4. Standard Operating Procedure of the Satpol PP, hereinafter referred to as SOP Satpol PP, is the procedure for the Regional Police and Public Order personnel, in order to increase awareness in carrying out the task of enforcing regional regulations in order to increase the awareness and compliance of the community, apparatus and legal entities to Regional Regulations, Regents Regulations and Regents Decisions and the organization of public order and community tranquility.

Article 2

The purpose of the SOP Satpol PP is as a guide for the Satpol PP in carrying out their duties to increase the compliance and obedience of the community to Regional Regulations, Regents Regulations and Regents Decisions and in organizing public order and community tranquility.

Article 3

The SOP Satpol PP aims to create uniformity in the implementation of the tasks of the Regional Police and Public Order personnel in accordance with their main tasks and functions.

CHAPTER II

STANDARD OPERATING PROCEDURE

Article 4

Regional Police and Public Order personnel in carrying out operational duties in accordance with the SOP Satpol PP.

Article 5

Basic principles of the SOP:

- a. Humane;
- b. Firm;
- c. Not arrogant;
- d. Not violating the law; and
- e. Continuity.

Article 6

(1) The SOP Satpol PP includes:

a. Administrative SOP, including:

- 1. Correspondence administration;
- 2. Attendance administration; and
- 3. Reporting administration.

b. Regional Order and Tranquility SOP, including:

1. Routine patrols;
2. Regulation of street vendors;
3. Regulation of vagrants and beggars;
4. Regulation of building permits;
5. Regulation of indecent acts and prostitution;
6. Regulation of alcoholic beverages;
7. Regulation of advertising;
8. Regulation of mining; and
9. Regulation of business permits.

c. Enforcement of Regional Regulations SOP, consisting of:

1. Summoning;
2. Guidance;
3. Non-judicial enforcement;
4. Judicial enforcement;
5. Investigation;
6. Investigation; and
7. Tipiring trial.

d. Security (PAM) SOP, consisting of:

1. Securing Government Activities;
2. Securing Community Activities; and
3. Escorts for guests/government officials.

e. Personnel Training/Physical Fitness SOP, including:

1. Arrival/departure roll call;
2. Personnel training; and

3. Physical fitness.

(2) The SOP as referred to in section (1), contained in the Appendix, is a single entity and an inseparable part of this Regulation of the Regent.

CHAPTER III

FINAL PROVISIONS

This Regulation of the Regent shall come into effect on the date of its enactment.

In order that everyone may be aware of it, the enactment of this Regulation of the Regent is ordered with its placement in the Regional Gazette of the Regency of Gresik.
