TO ESTABLISH AND MANAGE THE PURNA BHAKTI FOUNDATION

THE REGIONAL HOUSE OF REPRESENTATIVES OF REGENCY OF GRESIK

THE REGENT OF GRESIK

Considering: a. That with the enactment of Regulation of the Minister of Home Affairs Number 2 of 1990 concerning the Provisions of Purna Bhakti Allowance, a Foundation named the PURNA BHAKTI FOUNDATION OF THE REGIONAL HOUSE OF REPRESENTATIVES, abbreviated as YARNATI, was established;

b. That the Foundation referred to in letter a was established by the Minister of Home Affairs in accordance with the applicable laws and regulations based on the authority of the Regional Government;

c. That in connection with the above, the granting of authority of the Regional Government needs to be regulated by a Regional Regulation of the Regency of Gresik.

Considering: 1. Law Number 5 of 1974 concerning the Principles of Regional Government (State Gazette of the Republic of Indonesia of 1974 Number 38, Supplement to the State Gazette of the Republic of Indonesia Number 3037);

2. Law Number 12 of 1950 Juncto Law Number 2 of 1965 concerning the Formation of Regencies in East Java Province;

3. Law Number 8 of 1974 concerning the Principles of Personnel Affairs (State Gazette of the

Republic of Indonesia of 1974 Number 55, Supplement to the State Gazette Number 3307);

4. Government Regulation Number 38 of 1974 concerning the Change of Name of Surabaya Regency to Gresik Regency;

5. Government Regulation Number 5 of 1975 concerning the Management, Accountability and Supervision of Regional Finances (State Gazette of the Republic of Indonesia of 1975 Number 5);

6. Regulation of the Minister of Home Affairs Number 2 of 1990 concerning the Financial Status of the Chairperson, Deputy Chairperson and Members of the DPRD;

7. Regulation of the Minister of Home Affairs Number 1 of 1990 concerning the Provisions of Purna Bhakti Allowance for Members of the DPRD.

THE REGIONAL HOUSE OF REPRESENTATIVES OF REGENCY OF GRESIK,

RESOLVES

To Enact: REGIONAL REGULATION OF THE REGENCY OF GRESIK ON THE AUTHORIZATION TO THE MINISTER OF HOME AFFAIRS TO ESTABLISH AND MANAGE THE PURNA BHAKTI FOUNDATION OF THE REGIONAL HOUSE OF REPRESENTATIVES.

Article 1

In this Regional Regulation:

a. Region means the Regency of Gresik;

b. Regional Government means the Regency Government of Gresik;

c. Regional House of Representatives means the Regional House of Representatives of the Regency of Gresik;

d. Foundation means the Purna Bhakti Foundation of the Regional House of Representatives, abbreviated as YARNATI;

e. Purna Bhakti Allowance means the allowance given to all Members of the DPRD after the end of their term of office, or honorable discharge, or death;

f. Representation Allowance means the allowance given to the Leaders and Members of the DPRD every month in relation to their position.

## Article 2

To improve the welfare of the Purna Bhakti of the DPRD and the standardization of the type and system of allowance provision, it is necessary to establish an integrated institution, namely YARNATI, which is located in the Capital City of the Republic of Indonesia.

## Article 3

Purna Bhakti Allowance funds are sourced from:

- (1) Initial capital in the form of contributions from the Regional Government based on the Regional Revenue and Expenditure Budget of the Regency of Gresik, the amount of which is determined by the Minister of Home Affairs;
- (2) YARNATI's income consists of:
  - a. Mandatory contributions from DPRD Members every month, deducted directly at 10% (ten percent) of the Representation Allowance;
  - b. Contributions/assistance from Government Agencies and/or Third Parties;
  - c. Other legitimate income/businesses.

## Article 4

The Regional Government authorizes the Minister of Home Affairs to establish and manage YARNATI in accordance with applicable regulations.

## Article 5

The Regional Government will comply with the provisions that will be further stipulated in the Articles of Association and Bylaws of YARNATI regarding all consequences of the authorization in Article 4

of this Regional Regulation.

## Article 6

This Regional Regulation shall come into force on the date of its enactment and shall have retroactive effect from April 1, 1990.

In order that everyone may be aware of it, the enactment of this Regional Regulation is ordered by placing it in the Regional Gazette of the Regency of Gresik.
