THE REGENT OF GRESIK

Considering: a. That in order to increase the Regional Original Revenue in line with the current economic development, it is necessary to make the third amendment to Regional Regulation of the Regency of Gresik Number 10 of 1976 on the Use of Road Rollers Controlled by the Regency Government of Gresik.

b. That due to the rapid economic growth, it is necessary to amend the provisions referred to in letter a of this consideration by incorporating them into a Regional Regulation.

Considering: 1. Law Number 5 of 1974 on the Principles of Regional Government.

2. Law Number 12 of 1950 on the Establishment of Regency Areas within the Province of East Java, juncto Law Number 2 of 1965 on the Change of Boundary of Surabaya Municipality and Regency of Surabaya.

3. Law Number 12 N of 1957 on General Provisions on Regional Levies.
4. Law Number 3 of 1965 on Road Traffic and Transportation.
5. Government Regulation Number 38 of 1974 on the Change of Name of Surabaya Regency to Gresik Regency.
6. Decree of the Minister of Home Affairs Number 23 of 1986 on General Provisions Regarding Civil Servant Investigators in the Regional Government Environment.
7. Regional Regulation of the Regency of Gresik Number 10 of 1976 juncto Regional Regulation Number 2 of 1984 juncto Regional Regulation Number 16 of 1965 on the Use of Road Rollers Controlled by the Regency Government of Gresik.
8. Regional Regulation of the Regency of Gresik Number 10 of 1987 on Civil Servant Investigators.

With the approval of THE REGIONAL HOUSE OF REPRESENTATIVES OF REGENCY OF GRESIK

DECIDES

To enact: THE REGIONAL REGULATION OF THE REGENCY OF GRESIK ON THE THIRD AMENDMENT TO REGIONAL REGULATION OF THE REGENCY OF GRESIK NUMBER 10 OF 1976 ON THE USE OF ROAD ROLLERS CONTROLLED BY THE REGENCY GOVERNMENT OF GRESIK.

Article I

Regional Regulation of the Regency of Gresik Number 10 of 1976 on the Use of Road Rollers Controlled by the Regency Government of Gresik, which was ratified by the Decree of the Governor of East Java dated October 13, 1977, Number HKJI/258f77, was promulgated in the Regional Gazette of the Regency of Gresik dated November 29, 1977, Number 7 of 1977 Series B, was amended for the first time by Regional Regulation of the Regency of Gresik Number 2 of 1984 on the First Amendment to Regional Regulation of the Regency of Gresik Number 10 of 1976 on the Use of Road Rollers Controlled by the Regency Government of Gresik, ratified by the Decree of the Governor of East Java dated May 23, 1984, Number 226 of 1984, was promulgated in the Regional Gazette of the Regency of Gresik dated June 25, 1984, Number 7 of 1984 Series B, was amended for the second time by Regional Regulation of the Regency of Gresik Number 6 of 1985 on the Second Amendment to Regional Regulation of the Regency of Gresik Number 10 of 1976 on the Use of Road Rollers Controlled by the Regency Government of Gresik, ratified by the Decree of the Governor of East Java dated February 1, 1986, Number 3 of 1986, and was promulgated in the Regional Gazette of the Regency of Gresik dated February 21, 1986, Number 1 of 1986 Series B, is amended and supplemented as follows:

A. Section 5, subsection (1) is amended to read:

Every use of road rollers shall be subject to a daily levy, the amount of which is determined based on the list contained in the Appendix to this Regional Regulation.

B. Article 8 is amended and must be written

## CHAPTER V

### CRIMINAL PROVISIONS

#### Article 8

Violation of the provisions of Article 4, subsection (3) of this Regional Regulation shall be punishable by imprisonment for a maximum of 6 (six) months or a fine of a maximum of Rp. 50,000 (fifty

thousand rupiahs).

C. After Article 8, a new chapter on Investigative Provisions is added.

## CHAPTER VA

### INVESTIGATIVE PROVISIONS

#### Article 8A

(1) In addition to the Public Investigating Officials who are tasked with investigating criminal offenses, investigations into criminal offenses as referred to in this Regional Regulation may also be carried out by Civil Servant Investigators in the Regency Government of Gresik, whose appointments are determined in accordance with applicable laws and regulations.

(2) In carrying out their investigative duties, the officials as referred to in subsection (1) of this Article are authorized to:

- a. Receive reports or complaints from individuals regarding the existence of a criminal offense;
- b. Take immediate action at the scene of the incident and conduct an examination;
- c. Stop a suspect and check the suspects identification;
- d. Seize objects and/or documents;
- e. Take fingerprints and photograph a person;
- f. Summon individuals to be heard and examined as suspects or witnesses;
- g. Summon expert witnesses needed in connection with the examination of the case;
- h. Terminate the investigation after receiving instructions from the public investigator that there is insufficient evidence or that the incident does not constitute a criminal offense, and subsequently, through the public investigator, notify the public prosecutor, the suspect, or their family of this;
- i. Take other legally justifiable actions.

## Article II

This Regional Regulation shall come into force on the date of its promulgation. In order that everyone may be aware of it, the promulgation of this Regional Regulation is ordered by placing it in the Regional Gazette of the Regency of Gresik.

EXPLANATION OF THE REGIONAL REGULATION OF REGENCY OF GRESIK  
NUMBER 8 OF 1991

ON

THE THIRD AMENDMENT TO REGIONAL REGULATION OF THE REGENCY OF GRESIK  
NUMBER 10 OF 1976 ON THE USE OF ROAD ROLLERS CONTROLLED BY THE REGENCY  
GOVERNMENT OF GRESIK

I. GENERAL EXPLANATION

It is known that the development of the economic situation today has undergone many changes, both regarding its economic structure and the prices related to the economy itself. This situation will greatly influence the community, including the governments interests in carrying out its functions. Therefore, it is necessary to change the nominal tariff for the use of road rollers, considering that the nominal value of the old Regional Regulation is no longer in accordance with the current situation and to increase revenue.

This amendment to the Regional Regulation, in addition to changing the amount of the levy

mentioned above, also adds provisions regarding investigation in accordance with the letter of the Minister of Home Affairs dated June 1, 1985, Number: 182/576/SJ regarding Civil Servant Investigators (PPNS).
