THE REGENT OF GRESIK

Considering: that the provisions of the levies regulating the use of tents and chairs as stipulated in
Regional Regulation Number 2 of 1985 are no longer in line with current economic developments;
therefore, it is necessary to issue an amendment incorporated in a Regional Regulation.

Considering: 1. Law Number 5 of 1974 on the Principles of Regional Government;
2. Law Number 12 of 1950 on the Formation of Regency Areas within the Province of East Java,
juncto Law Number 2 of 1965 on the Amendment to the Boundary of the Surabaya Municipality and
the Type II Surabaya Area;
3. Law Number 12 Drt of 1957 on General Regional Levies Regulations;
4. Government Regulation Number 38 of 1974 on the Change of Name of Surabaya Regency to
Gresik Regency;
5. Regional Regulation of the Regency of Gresik Number 2 of 1985 on the use of Tents and Chairs
controlled by the Government of the Regency of Gresik.

RESOLVED

To Enact: THE FIRST AMENDMENT TO REGIONAL REGULATION OF THE REGENCY OF GRESIK NUMBER 02 OF 1985 ON THE USE OF TENTS AND CHAIRS CONTROLLED BY THE GOVERNMENT OF THE REGENCY OF GRESIK

Article 1

Regional Regulation of the Regency of Gresik Number 2 of 1985 on the use of Tents and Chairs controlled by the Government of the Regency of Gresik, ratified by the Decision of the Governor of the Type I Regional Head of East Java dated April 23, 1985 Number 109/P Year 1985, and promulgated in the Regional Gazette of the Regency of Gresik dated June 12, 1985 Number 1 Year 1985 Series B, is amended as follows:

A. CHAPTER V LEVY PROVISIONS Section 7, section (1) letters a and b are amended and added as follows:

a. Use of tents, per unit with a size of 6 X 6 M for;

1. One day, Rp. 15,000.00 (fifteen thousand rupiahs)
2. One week, Rp. 75,000.00 (seventy-five thousand rupiahs)

b. Use of Folding and Zinc Chairs per piece:

1. One day, Rp. 150.00 (one hundred and fifty rupiahs)
2. One week, Rp. 750.00 (seven hundred and fifty rupiahs)

c. Use of Chrome Folding Chairs per piece:

1. One day, Rp. 250.00 (two hundred and fifty rupiahs)
2. One week, Rp. 1,250.00 (one thousand two hundred and fifty rupiahs)

d. Use of Buffet Tables per unit:

1. One day, Rp. 1,000.00 (one thousand rupiahs)
2. One week, Rp. 5,000.00 (five thousand rupiahs)

B. Section 7, section (2) is amended as follows:

The amount of levy as referred to in section (1) letters a, b, c and d of this article does not include transportation costs and assembly and disassembly costs.

Article 11

This Regulation shall come into force on the date of its promulgation. In order that everyone may know it, the promulgation of this Regional Regulation is ordered by placing it in the Regional Gazette of the Regency of Gresik.

I. GENERAL EXPLANATION

As we know, current economic conditions have undergone many changes, both in terms of their economic structure and prices relating to the economy itself.

These conditions will greatly influence aspects of peoples lives, including the governments interests in carrying out its functions; therefore, it is necessary to change the nominal value for the use of tents, chairs, and buffet tables, considering that the nominal value of the old Regional Regulation is no longer in accordance with developments and to increase the Regional Original Revenue.

This amendment to the Regional Regulation, in addition to changing the amount of the levies mentioned above, also adds chrome folding chairs and buffet tables.
