The REGENT OF GRESIK,

Considering: a. that in order to improve public services and the proximity of functions and work load balance of the institution, it is necessary to amend the Regional Regulation of Gresik Regency Number 8 of 2010 on the Organization of Other Institutions as Regional Apparatus;

b. that based on the considerations as referred to in (a), it is necessary to issue a Regional Regulation on Amendment to the Regional Regulation of Gresik Regency Number 8 of 2010 on the Organization of Other Institutions as Regional Apparatus;

DECIDE:

To Enact: A REGIONAL REGULATION ON AMENDMENT TO THE REGIONAL REGULATION OF GRESIK REGENCY NUMBER 8 OF 2010 ON THE ORGANIZATION OF OTHER INSTITUTIONS AS REGIONAL APPARATUS.

Article I

Several provisions in the Regional Regulation of Gresik Regency Number 8 of 2010 on the Organization of Other Institutions as Regional Apparatus (Regional Gazette of Gresik Regency of 2010 Number 8), are amended as follows:

1. The provisions of Article 4 are amended, to read as follows:

Article 4

(1) The Regional Disaster Management Agency has the following duties:

- a. to establish guidelines and directions for disaster management efforts, including fire fighting and disaster prevention, emergency response, rehabilitation, and reconstruction fairly and evenly;
- b. to prepare technical instructions and implementation instructions for fire fighting and disaster management;
- c. to prepare, establish, and disseminate maps of disaster and fire prone areas;
- d. to prepare and establish standard operating procedures for disaster and fire management;
- e. to report the implementation of disaster management and fire fighting to the Regent once a month under normal conditions and at any time in emergency disaster conditions;
- f. to control the collection and distribution of money and goods;
- g. to account for the use of the budget received from the Regional Revenue and Expenditure Budget; and

h. to carry out other obligations in accordance with applicable legislation.

(2) The Regional Disaster Management Agency, in carrying out the duties as referred to in section (1), performs the following functions:

- a. the formulation and determination of policies on disaster management, fire fighting and refugee handling with quick, accurate, effective and efficient action; and
- b. the coordination of the implementation of disaster management and fire fighting activities in a planned, integrated and comprehensive manner.

2. The provisions of Article 5 are amended, to read as follows:

Article 5

(1) The organizational structure of the Regional Disaster Management Agency consists of:

- a. Head of the Agency;
- b. Director;
- c. Head of Implementation;
- d. Secretariat, consisting of:
 - 1) General and Personnel Sub-Section;
 - 2) Finance Sub-Section; and
 - 3) Program and Reporting Sub-Section.
- e. Prevention and Preparedness Division, consisting of:
 - 1) Prevention Section; and
 - 2) Preparedness Section.
- f. Emergency and Logistics Division, consisting of:
 - 1) Emergency Section; and
 - 2) Logistics Section.
- g. Rehabilitation and Reconstruction Division, consisting of:
 - 1) Rehabilitation Section; and
 - 2) Reconstruction Section.
- h. Fire Fighting Division, consisting of:
 - 1) PMK Development, Facilities and Infrastructure Section; and

2) Fire Fighting Operational Section.

i. Group of Functional Positions.

(2) The Organizational Chart of the Regional Disaster Management Agency is included in the Appendix to this Regional Regulation.

Article II

This Regional Regulation shall come into force on the date of its promulgation.

In order that everyone may be aware of it, the promulgation of this Regional Regulation is ordered by placing it in the Regional Gazette of Gresik Regency.

I. GENERAL

The essence of the Formation of Regional Apparatus Organization is to form a container to function as a tool in carrying out the tasks and functions of government. The Regional Disaster Management Agency is considered necessary to be given duties in fire fighting which technically is an object of Disaster. Because of the function of government as a regulator in the state system and in order to guarantee a sense of security for the community, the provision of fire fighting services is more appropriate to be carried out by the Regional Disaster Management Agency. With these considerations, it is necessary to amend Regional Regulation Number 8 of 2010 concerning Other Organizations as Regional Apparatus Institutions by including fire fighting affairs as duties inherent in the institution in question.
