THE REGENT OF GRESIK

Considering: a. That the provisions of parking service retribution on public roadsides and special parking places as stipulated in Regional Regulation of the Regency of Gresik Number 11 of 2001, in its implementation, have not yet regulated the use of parking on public roadsides and special parking places on a subscription basis;

b. That in order to provide opportunities for parking users to obtain subscription parking facilities, it is necessary to issue an amendment to the Regional Regulation referred to in point a above with a Regional Regulation.

RESOLVES

To Enact: THE REGIONAL REGULATION OF THE REGENCY OF GRESIK ON AMENDMENT TO THE REGIONAL REGULATION OF THE REGENCY OF GRESIK NUMBER 11 OF 2002 ON PARKING SERVICE RETRIBUTION ON PUBLIC ROADSIDES AND SPECIAL PARKING PLACES.

Article I

The provisions in Regional Regulation of the Regency of Gresik Number 11 of 2001 on Parking Retribution on Public Roadsides and Special Parking Places in the Regional Gazette of the Regency of Gresik of 2001 dated November 21, 2001 Number 2 Series C are amended with the following provisions:

A. Chapter I General Provisions Article 1 after point l is added with point m so it should be read as follows:

m. Subscription retribution is the payment for the use of parking spaces on public roadsides and special parking places placed on a subscription basis.

B. Chapter II Article 4 is amended and should be read:

Article 4

(1) The subject of Retribution is an individual or entity that uses parking spaces on public roadsides and special parking places, both subscription and non-subscription.

C. Chapter VI Article 8 is amended and should be read:

Article 8

The structure and amount of tariffs are set as follows:

1. For parking on public roadsides:

- a. Sedan, Jeep, Minibus, Pickup and the like Rp. 1,000,- per parking;
- b. Bus, Truck and other large equipment Rp. 2,500,- per parking;
- c. Motorcycle Rp. 500,- per parking

2. For parking in special places provided by the Regional Government, the tariff is the same as the tariff charged for each parking at parking places on public roadsides for non-subscription parking

users.

3. Provisions for subscription parking are further regulated by the Regents Decree.

Article II

(1) With the enactment of this Regional Regulation, Regional Regulation of the Regency of Gresik Number 11 of 2001 on Parking Retribution on Public Roadsides and Special Parking Places remains in effect except for those amended by this Regional Regulation;

(2) This Regional Regulation comes into effect on the date of its promulgation.

In order for everyone to know, the promulgation of this Regional Regulation is ordered with its placement in the Regional Gazette of the Regency of Gresik.
