The REGENT OF GRESIK,

Considering: that in order to implement the provisions of Article 311 section (1) of Law Number 23 of 2014 on Regional Government, as amended several times lastly by Law Number 9 of 2015 on Amendment to Law Number 23 of 2014 on Regional Government, and by adhering to the Regulation of the Minister of Home Affairs Number 38 of 2018 on Guidelines for the Preparation of Regional Revenue and Expenditure Budget for Fiscal Year 2019, it is necessary to issue a Regional Regulation on the Regional Revenue and Expenditure Budget for Fiscal Year 2019;

Article 6

(1) In an emergency, the Regional Government may make expenditures that are not yet budgeted in the Regional Revenue and Expenditure Budget for Fiscal Year 2019.

(2) In the event of an emergency occurring after the enactment of the Regional Revenue and Expenditure Budget for Fiscal Year 2019, the Regional Government may make expenditures that are not yet budgeted, and these expenditures shall be reported in the Budget Realization Report (BRR). Expenditures as referred to in this Article include expenditures for urgent needs.

(3) An emergency shall at least meet the following criteria:

- a. it is not a normal activity of the Regional Government and could not be predicted beforehand;

- b. it is not expected to occur repeatedly;
 - c. it is beyond the control and influence of the Regional Government; and
 - d. it has a significant impact on the budget in the context of recovery caused by the emergency.
- (4) Funding for emergencies that are not yet budgeted as referred to in section (1) may utilize Unforeseen Expenditures.
- (5) In the event that Unforeseen Expenditures are insufficient, it may be done by:
- a. utilizing funds from the rescheduling of the achievement of performance targets of other programs and activities in the current fiscal year; and/or
 - b. utilizing available cash.
- (6) Criteria for expenditures for urgent needs as referred to in section (2) include:
- a. programs and activities of basic public services whose budget is not yet available in the current fiscal year; and
 - b. other urgent needs which, if delayed, will cause greater losses to the Regional Government and the community.
- (7) The implementation of expenditures to fund activities in an emergency as referred to in section (1) shall be determined by a Regent Regulation.

Article 7

Further provisions regarding the details of the Regional Revenue and Expenditure Budget for Fiscal Year 2019 shall be regulated in a Regent Regulation.

Article 8

This Regional Regulation shall come into effect on the date of its promulgation.

In order for everyone to know, it is ordered that this Regional Regulation be promulgated by placing it in the Regional Gazette of the Regency of Gresik.
